A new state law (bill), ESHB 1261, now prohibits motorized and gravity siphon aquatic mining in some areas where it has historically taken place. It passed during this year's legislative session and mandates new permitting requirements.

On June 11, 2020, motorized and gravity siphon aquatic mining is prohibited in waters of the state that are critical habitat under the Endangered Species Act for salmon, steelhead, or bull trout, and all fresh waters of the state with designated uses of salmonid spawning, rearing, and migration.

Motorized and gravity siphon aquatic mining may still be allowed in areas that are not designated as salmonid habitat (potential use areas). See the interactive map of possible mining locations, called potential use areas. In potential use areas, operators of motorized or gravity siphon aquatic mining operations must now apply for and be issued an individual National Pollutant Discharge Elimination System (NPDES) water quality permit from Ecology to demonstrate compliance with the Clean Water Act. This is in addition to obtaining a Hydraulic Project Approval (HPA) permit from the Washington Department of Fish and Wildlife (WDFW).

What if I have a current HPA permit?

Starting June 11th, 2020 you will need both a HPA permit and an individual NPDES permit to legally conduct motorized and gravity siphon aquatic mining activities in a potential use area. Motorized and gravity siphon aquatic mining activities are not allowed in critical salmon habitat regardless of if the water from the mining activity is returned back (discharged) to the water body or to the ground.

Are there any types of mining allowed in the prohibited areas?

Yes. Non-motorized mining activities, such as gold panning, are still allowed in critical salmon habitat areas. These activities do not require an individual NPDES permit from Ecology, but will still require a HPA permit or approval under the Gold and Fish pamphlet from WDFW.

What should prospectors who were mining before June 11, 2020 do if they believe they should be issued a NPDES permit even though they're working below or above the ordinary high water mark in prohibited waters?

If you believe you qualify for a permit and are mining in or near waters that will become prohibited on June 11, 2020, please contact us using the information provided below to discuss the specifics of your mining operation. If we believe that your activity may be allowed under the new legislation, we will advise you to apply for an individual NPDES permit. After you submit your application, we will then conduct an in-depth review of the proposed discharge to make a final determination.

What are the permits required by the new legislation?

If you would like to conduct motorized or gravity siphon aquatic mining in the potential use areas you will need to:

 Apply for and be issued an individual National Pollutant Discharge Elimination System (NPDES) permit from Ecology. This will include the requirements you must follow in order to discharge water to surface water bodies, like lakes or streams, or to the ground during the mining process. Please note that you must apply for a NPDES permit at least 180 days prior to the start date of your mining operation. Visit Ecology's webpage (see below) for more information on applying for this permit.
Apply for a HPA permit from WDFW. For WDFW's HPA permit: go

WDFW's permits, please refer to its rules for mineral prospecting and placer mining

webpage. You must include a copy of a NPDES permit issued to you for each location at which you are proposing to operate or a letter from Ecology saying a permit is not required.
