General Meeting, November 14, 2021

Meeting was called to order by President Debbie Witcher at 2:15 PM.

Minutes of the October 10, 2021 General meeting were moved, seconded, and approved as read.

Treasurer - Deana Yoakum

Beginning balance: \$3,047.51; debits: \$1,678.27; income: \$619. Ending balance of

\$1,988.24. Debits included claims, storage unit, gas & hospitality food for meetings.

The report was moved, seconded, and approved to accept.

An audit was performed when the funds were transferred after the election of the new Treasurer Deana Yoakum. Audit found no problems.

The group now has a full board of 13 members. Introductions of Jason Roth, Jan Hurtubise, and Betty Erickson.

All SWW GP members can use group's claims, even if not a member of GPAA or LDMA.

It was approved to start selling the 3-month raffle tickets for January-March 2022 at December's meeting. The raffle will take place at the Gold Show (no need to be present to win). Raffle items include 1 week at Roaring Mining Camp, mini-sluice, gold nugget & more.

Committees:

Newsletter: Mark Mattila needs articles for the newsletter.

Gold Show – Jim Erwin: Next planning meeting will be at 1 PM on Sunday, January 23, 2022, at the Minnehaha Grange; donuts and coffee will be provided. Ron Koppi will pick the nugget out for the raffle.

There is a need for 10 people to volunteer to set up & tear down both Gold Shows (Puyallap March 26 & 27; here April 8, 9 & 10): this is very physical work.

Rick Dealer will the official photographer for both events.

T-Shirts for the event will be of a general nature of black with gold/yellow writing. Price is \$10/shirt by Designs of all Kinds for volunteers.

Postcard-sized information about the group can be used to give out to vendors that you would like to see represent us: give out cards, follow-up with calls, \$200 per booth. Debbie is checking into having the contracts printed for easy signing right on the spot.
